

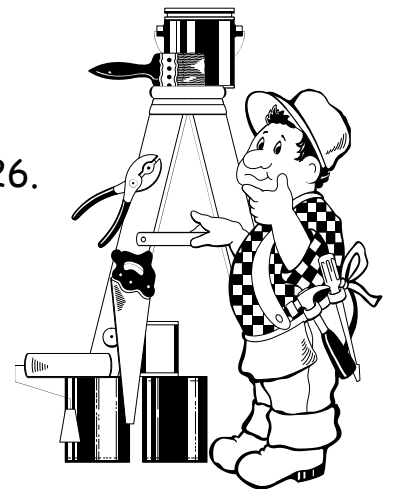
Could your home use a "FACELIFT"?

Consider a RDA Housing Facelift

Through the use of Redevelopment Agency funding, owner occupants may be eligible for reimbursement of exterior, "CURB APPEAL" type home improvement projects. Eligible exterior projects might include but are not limited to: paint, window replacements, siding, light fixtures, fencing and landscaping.

To determine if you are eligible to participate in this program, compare your entire household's income with the income limits below. You could receive up to \$2,000 in reimbursements to beautify and improve your home and yard.

Application RDA Housing “Facelift”

- All applicants must attach a copy of all household member’s completed and signed Federal Income Tax returns for the 2008 year, and a copy of the last three (3) months paycheck stubs and/or other income verification for all household members who are employed. Information provided by the applicant must be true to the applicant’s knowledge. Only applications from income eligible families will be considered for reimbursement. (See table below for Federal Income Limits)
- A picture of the home/rehab area is required with the application along with a detailed description of the “curb appeal” work to take place. Owners are permitted to provide their own labor but only labor performed by licensed contractors, and materials purchased from a licensed vendor or supplier will be approved for reimbursement. Only exterior “curb appeal” type home improvements will be reimbursed.
- Some projects may require a building permit. Please consult the City Building Department for more information.
- If painting is involved, please review the County “Lead Safe Housing Program” for additional information and resources. (You may qualify for additional funds.) <http://www.crd.slco.org/housing/housingLead.html>
- Only **South Salt Lake** owner-occupied homes are eligible.
- All applications will be reviewed by a committee and **pre-authorization required** for reimbursement up to \$2000 per household.
- The owner occupant is responsible to purchase all materials and pay all labor. The project must be complete in full before the City will reimburse any receipts. A City representative will confirm the project is complete as **pre-approved** and will issue a check for reimbursement after all paperwork is complete.
- The City reserves all rights to refuse payment of any reimbursement that does not meet the requirements of the program and the necessary authorizations. Reimbursement is subject to funding availability. **Reimbursements will not be issued without pre-authorization.**
