WHAT IS OUTDOOR STORAGE?

OUTDOOR STORAGE IS THE STORAGE OF MATERIALS, TOOLS, FURNITURE, HOUSEHOLD ITEMS, GOODS, PRODUCTS AND WARES, ETC. OUT OF DOORS.

NO OUTSIDE STORAGE IS PERMITTED IN ANY RESIDENTIAL OR BUSINESS DISTRICT OTHER THAN MOTORIZED VEHICLES, BOATS, OR CAMPERS THAT MEET THE REQUIREMENTS OF THE LAW: REGISTERED, LICENSED, OPERABLE, ETC.

STORAGE SHALL NOT BE PLACED IN A LANDSCAPED AREA AND WILL NOT BE ALLOWED IN REQUIRED PARKING AREAS.

MOTOR VEHICLES BEING REPAIRED SHALL NOT BE STORED OUTDOORS FOR MORE THAN 72 HOURS.

SMALL MOTOR VEHICLES BEING USED IN THE COURSE OF BUSINESS MAY BE PARKED OFF-STREET OUTSIDE THE BUSINESS DURING THE HOURS IT IS CLOSED.

MORE....

OUTDOOR STORAGE IS ONLY PERMITTED IN THE LIGHT INDUSTRIAL DISTRICT OF THE CITY.

WHAT CAN BE DONE?

IF IT IS DETERMINED THAT AN OUTDOOR STORAGE VIOLATION EXISTS, THEN A NOTICE WILL BE GIVEN OF WHEN TO CORRECT THE PROBLEM.
